



Ooredoo Palestine announced Net Profit of USD 3.9 million in Q1 2022 Customer base increased by 4% to reach around 1.4 million

Ramallah, Palestine, 15 May 2022: Wataniya Palestine Mobile Telecommunications Public Shareholding Company ("Ooredoo") - Ticker: "OOREDOO" at the Palestine Exchange, today announced its financial results for the three months ended 31 Mar 2022.

Operational Highlights:

- Revenues for Q1 2022 increased by 8% to USD 28.8 million, compared with USD 26.6 million in Q1 2021, driven by increase in data revenue
- EBITDA for Q1 2022 increased by 16% in Q1 2022 to USD 10.9 million, Compared with 9.4 in Q1 2021, supported by operational efficiencies
- Net Profit was USD 3.9 million for Q1 2022, representing a strong growth of 52% compared to USD 2.6 million in Q1 2021. The growth was driven by operational performance and revenue growth
- Customer base increased by 4% to reach around 1.4 million in Q1 2022.

Dr. Durgham Maraee, Chief Executive Officer of Ooredoo Palestine commented:

"Ooredoo Palestine delivered a healthy set of results for the start of the year, reporting an 8% increase in Revenue to USD 28.8 million in Q1 2022 compared to the same time last year, with an improvement in EBITDA by 16% to USD 10.9 million. The company's focus on operational efficiency supporting an improved EBITDA margin of 38% in Q1 2022 and delivering 52% growth in Net Profit to USD 3.9 million in Q1 2022 compared with USD 2.6 million in Q1 2021. In addition, focusing on customer experience
