

## Ooredoo Palestine Reports Net Profit of USD 7.2 million for H1 2022 Customer base increased by 5%

**Ramallah, Palestine, 14 Aug 2022:** Wataniya Palestine Mobile Telecommunications Public Shareholding Company (“Ooredoo”) - Ticker: “OOREDOO” at the Palestine Exchange, today announced its financial results for the six months ended 30 June 2022.

### Operational Highlights:

- Revenues increased by 8% to USD 57.5 million in H1 2022, compared to USD 53.5 million in H1 2021, driven by increase in data revenue
- EBITDA increased by 11% in H1 2022 to USD 21.5 million, Compared to USD 19.3 million in H1 2021, supported by operational efficiencies
- Net Profit increased by 25% to USD 7.2 million in H1 2022, due to improved operational performances
- Customer base increased by 5% to reach around 1.4 million in H1 2022, driven by pre-paid and post-paid mobile

Dr. Durgham Maraee, Chief Executive Officer of Ooredoo Palestine commented:

“Ooredoo Palestine reported solid results in the H1 2022 with revenue growing by 8% compared to last year and an increase in net profit by 25%. Furthermore, our subscriber base grew by 5%. Ooredoo Palestine continues to lead the market in customer satisfaction. Our newly launched app
