

## Ooredoo Palestine reported a healthy 7% YoY increase in net profit to USD 3.4 million in Q1 2025

## Strong customer growth of 6% YoY to reach 1.55 million

Ramallah, Palestine, 29 April 2025: Wataniya Palestine Mobile Telecommunications Public Shareholding Company ("Ooredoo") - Ticker: "OOREDOO" at the Palestine Exchange, today announced its financial results for the first quarter ended 31 Mach 2025.

Operational Highlights:

- Revenue for Q1 2025 reached USD 25.8 million. Compared to USD 26.6 million in Q1 2024, impacted by the challenging operating environment.
- EBITDA for Q1 2025 stood at USD 9.7 million, reflecting a 4% decrease YoY with a corresponding EBITDA margin of 37.5%, affected by the current on-the-ground circumstances.
- Net Profit for Q1 2025 increased by 7% reaching USD 3.4 million compared to USD 3.2 million for Q1 2024.
- Customer base increased by 6% to close the quarter at 1.55 million customers for Q1 2025 compared to 1.45 million in Q1 2024.

Dr. Samer Fares, Chief Executive Officer of Ooredoo Palestine commented:

"I am pleased to announce that we started the 2025 year with solid results, reflecting the resilience of our operations and our team's continued commitment.

In Q1 2025, our net profit increased by 7% YoY, reaching USD 3.4 million in Q1 2025, while revenue stood at USD 25.8 million, EBITDA recorded a decrease of 4% YoY to USD 9.7 million. Despite this, we achieved a



healthy growth in our customer base of 6% reaching 1.55 million customers, reflecting our expanding market presence and strong brand loyalty.

Looking ahead, we remain committed to driving sustainable growth and delivering innovative digital experiences. With a focus on operational efficiency, customer satisfaction, and strategic investments, we aim to maintain our progress and sustainable performance ".
