



Ooredoo Palestine reported Net Profit of around USD 6 million

for the Nine Months Ended 30 September 2020

Ramallah, Palestine, 01 Nov 2020: Wataniya Palestine Mobile Telecommunications Public Shareholding Company ("Ooredoo") - Ticker: "OOREDOO" at the Palestine Exchange, today announced its financial results for the nine months ended 30 Sep 2020.

Operational Highlights:

- Revenues for the nine months ended 30 September 2020, stood at USD 75.2 million, compared with USD 72.9 million for the same period in 2019
- EBITDA increased by 18% for the nine months ended 30 September 2020 to USD 25.2 million, compared to USD 21.4 million for the same period in 2019, indicating a strong operational performance and cost control
- Net Profit for nine months ended 30 September 2020 amounted to around USD 6 million, compared with a USD 0.7 million loss for the same period in 2019, as a result of strong operational performance
- Customer base increased by 3% to reach more than 1.3 million at the end of September 2020.

Dr. Durgham Maraee, Chief Executive Officer of Ooredoo Palestine commented:

"Despite the challenging market conditions, Ooredoo Palestine improved profitability levels during the nine months ended 30 September 2020, with an increasing net profit reaching around USD 6 million, compared with USD 0.7 million loss for the same period in 2019. This is testament to the company's strong performance and cost optimization, Ooredoo Palestine delivered 18% growth in EBITDA to reach USD 25.2





million, and 3% growth in revenues to reach USD 75.2 million. We remain committed to delivering innovative services and a differentiated customer experience."
